Corrigendum no. 3

Addition of New Clause

The following clause is hereby added to the Tender Document under "PART-2 of Section-5: Supplementary Technical Specifications & Drawings" and shall be read as part of the tender conditions:

Clause No. 11.19.2

The Contractor shall establish a dedicated Help Desk with contact details for addressing complaints, maintenance issues, and service requests within 7 days from the date of commissioning of the system.

Penalty for Delay in Help Desk Setup.

If the Contractor fails to establish the Help Desk within the stipulated period:

- A penalty of ₹1,000 (Rupees One Thousand only) per day shall be levied for each day of delay beyond the allowed period until the Help Desk becomes fully operational.
- If the Help Desk is not established within 15 days of commissioning, the department reserves the right to:
 - o Forfeit the Performance Security, and/or
 - Engage third-party services for Help Desk operations at the risk and cost of the Contractor, with all expenses recovered from pending bills or security deposits.

Clause No. 16.2

NAME PLATE ON HIGH MAST LIGHT

The contractor shall provide and fix a name plate on each high mast light as per the design and information / wording provided by the department.

The name plate shall be made of stainless steel or anodised aluminium with a thickness of not less than 1.5 mm, ensuring weather resistance and long service life.

The name plate shall be engraved or embossed as per approved design and fixed securely on the mast at an accessible height using stainless steel screws or rivets as directed by the Engineer-in-Charge. The rate quoted shall include the cost of all materials, fabrication, engraving, transportation, labour, fixing, T&P, and all incidental charges to complete the work in all respects.

Note: All other terms and conditions of the Tender shall remain unchanged. This corrigendum shall be treated as an integral part of the Tender Document.
